### **DEFEXPO-2022 - POLICY FOR REFUND / COSTS OF COMPENSATION**

1. DefExpo-2022 has been postponed and the new dates would be worked out in consultation with the host State based on an assessment that the constraints leading to the postponement in the first instance would not be faced. To acknowledge the investments of the participants, the policy provides for either Costs of Compensation with retention of the reserved space for the revised dates of DefExpo-2022 or 100% refund of the payment received as follows:-

#### **Costs of Compensation:-**

- (a) 20% refund for MSMEs who have booked 12sqm space and availed the 50% MSME discount as per the Terms and Conditions. The 20% refund will be on the total amount of the stall charges (received in full) or part payment amount received from the participant whichever is lesser.
- (b) 10% refund to non-MSME participants on their space charges (received in full) or part payment amount received whichever is lesser.
- (c) The costs of compensation will be offered to the participants opting to stay with DefExpo-2022 and same space (venue being the same) will be reserved.

OR

#### **Refund Policy:-**

- (a) 100% refund for Indoor space, Chalet and Outdoor space of amount received by DEO. Also, Business visitor tickets and registration charges of Rs 40000/- (paid by participants without space booking), Sponsorship amount (Gold and Silver) and royalty taken from individual stand fabricators (other than Official Fabricator) will be fully refunded.
2. Please provide the Bank details for conveying of the selected option either for Costs of Compensation OR 100% refund in the format as per Annexure-I.
3. Tax Invoice will only be provided to participants opting for Costs of Compensation equivalent to the retained balance viz Total amount minus Costs of Compensation. Accordingly, duly filled Annexure-I is to be forwarded to email ID [defexpo@ddpmod.gov.in](mailto:defexpo@ddpmod.gov.in) latest by 22 April 2022.
