Terms & Conditions for Sponsorship

- Sponsorship packages are limited to only the Exhibitors in DefExpo – 2022 and application for the sponsorship packages can be made only online through the Defexpo – 2022 website.
- The prospective Sponsor and it's associated entities / subsidiaries should not have been blacklisted by any investigating agency / Govt. agency. By applying for any of the Sponsorship packages in DefExpo – 2022 the prospective Sponsor undertakes to be complying the said condition.
- Sponsorship packages are offered on First Come First Serve basis. Realization of 100% payment in the Organizers's Account (DEO's Account) on first come basis for a particular sponsorship package would be considered as precedence for acceptance of sponsor.
- Payments to the Organizer for sponsorship is to be done online through DefExpo – 2022 website links provided and not by any other means.
- **Last Date for application for Sponsorship packages – 18 Feb 2022**
- Soft copies of logo, print material, etc. in formats as essential have to be provided by the successful sponsors. The printing and Installation etc. will be carried out by the Organiser.
- The discretion of the Organiser will be final in terms of dimension, location of installation etc. whichever is not specified in the description.
- The organisers, at any time, reserve the right to alter the sponsorship packages in which case the Organiser will make reasonable effort to inform the sponsors about the changes.
- The sizes of the Logos, standees and other promotional material will be decided by the Organiser and the Event Manager based on the Location and the visibility.
- In the event that the Sponsor changes the Logos at any time during the Term, the sponsor agrees that the organisers shall not be obliged to make any consequential changes to materials that include the Logos produced by the organisers or on their behalf for or in connection with the Event (including, but not limited to, reprinting promotional literature or publicity materials) unless the Sponsor agrees in writing in advance to meet the costs and expenses incurred by the organisers arising from such change.
- The sponsor shall, prior to distributing any promotional materials referencing the Event and/or using the Event Marks (the "Client Literature"), provide copies of the Client Literature to organisers for their approval (not to be unreasonably withheld). The sponsor undertakes that he shall not distribute any Client Literature until he has received written confirmation from the organisers approving the Client Literature. The sponsor is solely responsible for meeting all costs relating to the Client Literature (including reprinting costs if approval is not obtained prior to printing).
- The organisers acknowledge all intellectual property rights (including, but not limited to, copyright, trademarks and design rights) in the Sponsor Marks shall be solely and exclusively owned by the sponsor, together with any goodwill therein, and the organisers shall not acquire any rights in the Sponsor Marks.
